## 4.1 Council Remuneration Review (FIN24-032)

- at the October 2024 AMO Workshop Forum, discussion was held regarding healthy democracy and how municipalities can attract varying demographics to municipal involvement and Council; and
- Council being full or part time work as well and the renumeration amount being important to removing barriers for lower income individuals to participate.

4.2 New Multi-Residential Property Subclass (FIN24-031)

**Staff Recommendation:** THAT the Report titled, "New Multi-Residential Property Subclass" (FIN24-031), be received for information.

**Sub-committee Discussion:** Members of Sub-committee and the Director of Corporate Services discussed the report. Highlights of the discussion included:

- the new legislation being concerning as Stratford would have three multi-residential property classes, with the new class being of a different tax class than existing multi-residential classes;
- this being a complex topic making it challenging for municipalities to fund housing as provincial changes like this are funded by the municipality;
- the provision of provincially mandated services at current funding levels being challenging and this being a further reduction providing an additional challenge;
- staff noting this legislation could be used as a tool to achieve local housing goals if, after further review, this was identified as the preferred method;
- under this legislation a property development would meet the criteria by providing a certain number of affordable rental units and this not being under Council control; and
- this legislation having been released in the Summer 2024 and staff looking to larger municipalities as reference to approach this prior to setting the Stratford 2025 tax rates.
