# 5. Hearings of Deputations and Presentations

5.1 ADDED – Property Taxes and Impact on Seniors – Safe Haven Perth

# Committee Decision: THAT Baiba Wilde on behalf of Safe Haven Perth be heard.

#### Carried

Baiba Wilde spoke to Committee on behalf of Safe Haven Perth. Highlights of the presentation included:

- their organization working with people in poverty, and homeless individuals in Kitchener;
- Safe Haven Perth providing assistance for first time homeless individuals;
- increased taxes affecting seniors dealing with the cost of living increase, decreased income and debt resulting from maintenance and renovations which contain high interest;
- property taxes being a catalyst for going into debt;
- there being a rise of seniors becoming homeless;
- there being a crisis in this demographic with the rising cost of living and increases in households receiving assistance from the food bank;
- their organization seeing a spike in homelessness in a two-year period; and
- suggesting that policies be developed to provide tax relief for eligible seniors.

Discussion was held on the experience of seniors in Stratford and on the possibility of a tax relief program.

# 5.2 ADDED - Strategic Priorities and the Community Climate Action Plan – Jane Marie Mitchell

Jane Marie Mitchell spoke to Committee about the City's strategic priorities and the Community Climate Action Plan. Highlights of the presentation included:

• an overview of Stratford's strategic priorities being provided;

- noting emissions from the city and the members of the public;
- educating the public and advising them on what they can do to reduce their emissions being especially important during this time as environmental issues occur;

- there being a lack of awareness by the public about the Idling Bylaw; and
- urging Council to fulfill its commitment and to revisit the Community Energy Liaison.

# 4. Treasurer Update

The Director of Corporate Services/Treasurer, referring to a PowerPoint presentation, provided an update on the draft 2025 budget.

It was questioned what the average impact is. The Director of Corporate Services/Treasurer advised it is approximately \$354 for the average resident who has an assessed value of \$350,000. This translates into a \$30 increase per month.

# 6. Draft 2025 Budget Deliberations

**Committee Discussion:** Concerns were expressed about the increased tax levy and a request was made to defer all staff expansions with a levy impact, excluding the Backflow Prevention Officer and the Ontario Works Caseworker.
