- 6.1 Confidential Report of the City Clerk with respect to Applications for a Vacancy on the Committee of Adjustment (CM-25-12) - Personal matters about an identifiable individual(s) including municipal employees or local board employees (section 239.(2)(b)).

Councillor Sebben requested that Item 5.1 be taken separately.

With respect to Item 4.1, Councillor Sebben stated that although Council may be permitted to provide direction in a closed session on this item that any direction should be given in open session. For Item 5.1, Councillor Sebben advised they do not support moving into closed session for this item, discussion should only be had after the fulsome report on public input is presented for consideration.

The Interim Chief Administrative Officer advised the items noted are under the exemptions in the Municipal Act dealing with negotiations.

Councillor Henderson noted one of the letters received is marked 'privileged and confidential' and that permission would be required to deal with that item in open session.

Councillor Wordofa now present at the In-camera Session at 4:34 p.m.

Mayor Ritsma called the question on Items 4.1 and 6.1.

On item 5.1, Councillor Sebben requested a recorded vote. Councillor Sebben noted this discussion should occur after Council decides on whether to dispose of the subject property.

Councillor Hunter noted that if the intent is to sell the land for \$1.00 they would be opposed. If the intent is to sell the land for \$20 million then they would be in favour.

Councillor Hunter further noted that Council can give guidance to the City's Solicitor and senior staff on what is to be negotiated and then be in a position to vote on the matter.
