6. Report of the Clerk

6.1 Composition and Size of Council for the 2026-2030 Term (FIN25-025)

Staff Recommendation: THAT direction be provided if City Council is interested in initiating notice of intent to change the composition of City Council in time for the 2026 municipal election and that City Council identify the proposed change(s) to the composition and/or size of Council.

Sub-committee Recommendation: THAT City Council initiate the notice of intent process to change the composition of City Council to 9 members (8 Councillors and a Mayor) in time for the 2026 municipal election.

THAT City Council initiate the notice of intent process to change the composition of City Council to 9 members (8 Councillors and a Mayor) in time for the 2026 municipal election.

Committee Discussion: Members of the Committee held a discussion regarding the following:

- the motion being brought forward in consideration of the role of council, the amount of remuneration, and comparison of Council composition in other municipalities of the same size;
- the remuneration budget being kept the same and the salary level of the members being increased;
- the proposed change in the Procedural By-law to move from a three-step process to a two-step process resulting in a decrease in meetings;
- the decrease in the size of Council potentially resulting in an increase to the strong mayor powers;
- the discussion of the composition of Council being deferred to the same time as the discussions on the procedural by-law review;
- there being public consultation to be done if the Council composition review proceeds;
- there being concerns with the impacts to diversity and representation in Council should the decrease proceed;
- there being no requests from the public to reduce the size of Council and the remuneration having been reviewed previously by a committee;

A member requested a recorded vote.

- a member noting they are in favour of maintaining the current structure;
- the proposed change resulting in a small increase in the salary but would affect representation and diversity as well as the workload distribution;
- the current compensation only attracting certain people who can afford to do the job and the increase in remuneration would allow people who would not otherwise run for Council;

- single-tier municipalities having a similar council size as Stratford and lower-tier municipalities having smaller councils;
- there being concerns with the impact of the decrease in the Council size to the strong mayor powers and the minimum requirements to pass items;
- there being other options to explore to improve representation in Council such as allowing hybrid attendance at meetings;
- the community continuing to grow and having more Council members being beneficial to the community;
- the City being better served by having a ward system in place to increase accountability resulting in better representation; and
- there being different data points which can be collected to understand how Council can be more representative and how Council can better serve the public.

The motion was withdrawn.

6.2 Appointment of Deputy Mayor (FIN25-023)

Staff Recommendation: THAT direction be given to the City Clerk on the process for selecting a Deputy Mayor for the City commencing with the 2026-2030 term of office.

Sub-committee Recommendation: THAT direction be given to the City Clerk to develop a policy outlining a process for selecting a Deputy Mayor by rotation, with a maximum of four (4) Councillors permitted to serve in the role per term, and commencing with the 2026-2030 term of office.

Committee Discussion: Members of the Committee held a discussion regarding the following:

- it being proposed that members interested in the Deputy Mayor role put their name forward at the beginning of the term;
- the proposed process being similar to the one currently being used by Ottawa City Council to appoint a Deputy Mayor;
- there being members who may be hesitant to step in to the role at the beginning of the term but may be interested in the opportunity later;
- a member noting they like the idea of having more opportunity but have concerns regarding a lack of continuity;
- it being valuable for Council members to select a person who they trust can best step into the role.

THAT the motion be amended to include that the current process of Council selecting the Deputy Mayor be maintained.

THAT the Deputy Mayor be appointed for a two-year term based on the highest number of votes and subject to the candidate accepting the role.

Members of the Committee and staff held a discussion regarding the motion as follows:

- it being questioned whether the members who will serve as Deputy Mayor are being selected based on the highest number of votes;
- where most of the Council members are new, it being better to leave the choice of Deputy Mayor to the hands of the electorate;
- the Interim Chief Administrative Officer noting that the Deputy Mayor is an important role;
- there being candidates who may wish to serve the public as a councillor only and may not be positioned to serve as a Deputy Mayor;
- a provision being added that the appointment of the member with highest votes as Deputy Mayor being subject to them accepting the role; and
- a two-year term being preferred as it allows Council the ability to pause and review.

The Chair called the question on the motion.

THAT the current process for the selection and appointment of Deputy Mayor be maintained.

It was questioned and confirmed that appointing a Deputy Mayor is not one of the powers provided for in the Strong Mayor Power legislation.
