- the purpose of the Committee being to improve community responses to victims of domestic violence;
- the availability of training and education sessions on how to live a life free of violence;
- launching of a new website to ensure services and communications are continued during the COVID-19 pandemic;
- 2019 data showing fewer cases of sexual assault but higher cases of overall charges including domestic violence and human trafficking;

- higher waitlist numbers for social, safe and affordable housing, including women and children on the second stage waitlist;
- increased number of cases during the COVID-19 pandemic being attributed to social distancing requirements and being at home more often;
- a snapshot of 2020 data being made available next year;
- the new Survivors Advisory group established to provide advice to the Committee from a more diverse number of survivors across the community;

Enbridge Gas Inc. has applied to raise its natural gas rates effective April 1, 2021, to recover costs associated with the federal government's *Greenhouse Gas Pollution Pricing Act.*

Enbridge Gas Inc. (Enbridge Gas) has applied to the Ontario Energy Board for approval to increase its rates effective April 1, 2021, to recover the costs associated with meeting its obligations under the federal government's *Greenhouse Gas Pollution Pricing Act*.

The *Greenhouse Gas Pollution Pricing Act* establishes a carbon pricing program under which a natural gas utility in Ontario, such as Enbridge Gas, is required to pay a carbon charge to the federal government for emissions from the natural gas that it delivers to its customers, and for excess emissions from the operation of Enbridge Gas's natural gas distribution system. The federal carbon charge came into effect on April 1, 2019, increased on April 1, 2020, and will increase again on April 1, 2021.

Enbridge Gas says that if its application is approved as filed, it will have the following bill impacts:

- A typical residential customer in the EGD rate zone (former customers of Enbridge Gas Distribution Inc.) will see an annual bill increase of \$47.08.
- A typical residential customer in the Union rate zones (former customers of Union Gas Limited),
 will see an annual bill increase of \$43.23.

Other customers, including businesses, will also be affected.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The OEB will hold a public hearing to consider Enbridge Gas's application. During this hearing, which could be an oral or written hearing, we will question Enbridge Gas on its application. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing.

Title: Municipal Golf Course Renewal Agreement

Objective: To consider renewing the agreement with the Stratford Municipal Golf Course Association for the lease of the golf course on Norfolk Street from 2021-2023 and to amend the annual fees to be collected.

Background: The Golf Course was leased to the Stratford Municipal Golf Course Association in 1980 and was continually renewed through to 1996. The entire lease was renewed in November 1996 for a twenty-one-year lease period, expiring December 30, 2017. The lease stipulated renewals every three years with the same terms and conditions as the original lease except for the yearly rental rates which were to be negotiated.

Included in the agreement:

- The Association pays all expenses incurred in the operation and maintenance for grass cutting, plant material, fertilizing and equipment;
- The Association is responsible for repairs caused by wear and tear;
- Any alterations must first be approved by the City of Stratford;
- The Association carries insurance to protect itself and indemnify the City harmless from all claims;
- The Association obtains approval of Council each year for green fees and membership fees.

At the end of the 2009, 2010, 2011 term, the agreement was renewed for a one-year term (2012) with a lease amount of \$20,000, with \$2,000 of this amount going into a reserve for use by the Golf Course Association.

The Stratford Municipal Golf Course Association presented at Sub-committee in January 2016 requesting a change to the agreement and that it be renewed for another two years.

Their request was that the total annual lease payment (\$20,000) be paid and put into a reserve fund to enable the Association to achieve their short-term goals.

The agreement was once again renewed for 2016 and 2017 with the annual lease payments put into a reserve fund for use by the Golf Course.

In 2018, a new lease agreement was entered into for a three-year period from 2018-2020. The agreement provides for two three-year renewals, with the terms remaining the same, however the annual fees are required to be negotiated.

Analysis: The Golf Course Association has requested a renewal of the lease agreement, for the lease payment to remain at \$20,000 and for that amount to be placed into the reserve fund for future expenses.

Financial Impact: Revenue into reserve account as listed below. City staff provide bookkeeping services such as payroll, accounts receivable, accounts payable, bank reconciliation, etc. The cost to provide these services is approximately \$12,000 per year.

Title: City Space for Online Learning

Objective: To provide information to Committee on the City-owned space available with free wi-fi for online student learning.

Background: At the October 13, 2020 Regular Council meeting, Council adopted the following recommendation of the Community Services Committee:

THAT staff look into providing a City space for online learning, including hand sanitizer and access to free wireless internet;

AND THAT staff provide an updated list of current spaces throughout the City that offer access to wireless internet for online learning.

This motion was in response to a need brought forward to Councillor Beatty from a member of the education sector regarding students in post-secondary and secondary school that require an alterative location for online learning, other than their home.

Analysis: Currently the City offers free wi-fi in the following facilities:

- City Hall
- Public Library
- Dufferin Arena
- Allman Arena
- Rotary Complex
- Agriplex
- 82 Erie Street
- Fire Hall 1 & 2
- Anne Hathaway Daycare
- Public Works

Three locations that would be conducive for online learning would be the Rotary Complex, the Burnside Agriplex and the Library.

Library

- Hours are 10am 8pm Monday to Thursday and Friday and Saturday until 4:00pm
- 1 hour 45-minute appointments available for anyone wishing to use tablespace at the library to study, use a laptop or use one of the Library's Chromebooks
- Table and chair provided, and wireless printing, scanning and photocopying are available (cash and debit accepted)
- All users are required to maintain physical distancing and wear a face covering

Rotary Complex

- Washrooms, hand sanitizer available
- Students could come and use tables and chairs that are currently set up in the downstairs and upstairs lobbies
- If they require a quieter space, they could approach facility staff to see if a meeting room is available (such as the Tim Taylor Lounge or Games Room)
- All students would be required to physically distance and wear a face covering when inside the facility

Agriplex

- Washrooms, hand sanitizer available
- Students would approach facility staff to see if a meeting room is available (such as the Ritsma Room)
- All students would be required to physically distance and wear a face covering when inside the facility

Hours of use at both the Agriplex and Rotary Complex would be 8:00am – 9:00pm, seven days a week.

The Community Halls at the Rotary Complex as well as the meeting room on the hall side of the building are not available as the Huron-Perth Health Care Alliance (HPHA) require an indoor facility and will be using the halls for their COVID-19 assessment site from November 1, 2020 through to spring 2021.

Title: Bedding Plants 2021 - 2024

Objective: To authorize the award of Tender T-2020-36 for the supply and delivery of bedding plants for 2021 through 2024.

Background: The Community Services Department recently put out a tender to supply and deliver bedding plants for a four-year period of 2021, 2022, 2023 and 2024. The tender closed on October 7, 2020 with one submission received.

Due to COVID, in 2020 the hiring of seasonal staff was paused. The decision was made in March to only plant gardens at Avondale Cemetery, Memorial Gardens and in front of City Hall.

Analysis: The award of the tender is to one bidder for the entire four-year term. The average number of plants used over the past four years is as follows:

1 – Annuals 4/pack – 48/flat	47,000
2 – Annuals cuttings 4/pack – 48/flat	20,000
3 – Annuals 4" pot – 15/flat	10,000

Although there was only one bidder, the department finds the prices are comparable to previous years' tender.

Considering the 2021 budget in Community Services, there is a need to reach a goal of less than a 2% increase. Savings can be achieved by operating with a reduced staff and only planting beds at Avondale Cemetery and City Hall and putting out all hanging baskets and sidewalk planters in downtown core for 2021.

The Community Services Department has until mid-December to advise the nursery of our plans for 2021 as the nursery needs to know how much greenhouse space they require for our plants. We would be invoiced for only what we purchase.

Financial Impact: Breakdown of yearly cost is as follows:

2021 - \$38,140 plus \$4,958.20 HST

2022 - \$82,330 plus \$10,702.90 HST

2023 - \$83,850 plus \$10,900.50 HST

2024 - \$85,450 plus \$11,108.50 HST

WHEREAS Section 8.(1) of the *Municipal Act, 2001, S.O. 2001, c.25 as amended,* provides that the powers of a municipality under this or any other Act, shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS by agreement dated the 11th day of December, 2017, The City and the Golf Course Association hereto entered into a Lease Agreement ("the Agreement") setting out the terms and conditions of the lease of the Golf Course property on Norfolk Street by the City to the Golf Course Association;

AND WHEREAS the City and the Golf Course Association wish to enter into a further three-year extension to the said Agreement dated December 11, 2017 under the same terms and conditions with minor exceptions set forth in the Amending Agreement:
