The Accessibility Advisory Committee presents an accessibility award to a local business each year in recognition of the International Day of Persons of Disabilities.

Diane Sims appeared before Council to announce the recipient of the 2020 accessibility award, Infinity Dance Studio at 451 Erie Street. Ms. Sims read a portion of the application form submitted. She advised she visited the site, along with a fellow member on the Committee, and saw many different classes offered with pictures on the walls, including some people in wheelchairs. The studio also has an accessible door with a bell when opened. The hallways are accessible with rails and the whole environment is welcoming to someone with mobility or visual disabilities. Programs are available for people of all ages and accessibility levels.

Jeanine Henderson-Kitching was present and advised that Infinity Dance was celebrating its 10th year and it was an incredible honor to receive this award.

Mayor Mathieson provided his congratulations to the recipient.

Tony Ghaeinizadeh appeared before Council and stated that this problem began in 2011 when litigation was commenced to deal with a contamination issue. A trial date was set for April 1, 2020 and a payment of \$20,000 was made recently. The property was mostly vacant up until late 2017 and over \$250,000 has been spent in environmental and professional fees. Anything that has been made to date has been used to pay off penalties. The agreement for extension to pay off the remaining balance will make it difficult to maintain and involves paying over \$150,000 in penalties. Mr. Ghaeinizadeh requested the City work with them on forgiving a part of the outstanding penalties and allowing until the end of January or February to pay off the sum of \$175,000.

*Councillor Ritsma departed the meeting at 3:15 p.m.

Discussion ensued with respect to:

- an overview of the payments made to date, including \$78,000 received since 2011;
- one request being received in the last 13 years for relief on interest which was denied;
- the annual tax bill being between \$18-19,000.
