**Title:** Rapid Housing Initiative (RHI)

**Objective:** To obtain Council endorsement to submit a proposal to Canada Mortgage Housing Corporation (CMHC) for the Rapid Housing Initiative (RHI) for the development of an Alternative Housing Pilot project.

**Background:** The Government of Canada and CMHC recently launched a brand-new program called the RHI to expedite the construction of 3,000 new affordable housing units for vulnerable people in severe housing need, specifically people at risk of or experiencing homelessness, or living in temporary shelters because of the COVID-19 pandemic.

CMHC will contribute "up to 100%" of eligible residential construction costs for the following forms of housing only:

- The construction of a "modular" multi-unit rental project, which includes the acquisition of the land. (Land is already owned by the City and the City can use the land value as our contribution to the project)
- The acquisition and conversion of a non-residential building to an affordable rent project. (This option is not recommended as a viable option given the timelines to acquire a property and to convert.)
- The acquisition of an existing building in state of disrepair or abandoned for the purpose of rehabilitation where units were previously lost from the housing stock. (This option is not recommended as a viable option given the timelines to acquire and rehabilitate.)

Modular is defined as housing units that are partially or fully built off-site (e.g. a factory, warehouse, or similar facility) by a qualified manufacturer and delivered to the site in whole or in parts and installed on an appropriately zoned and serviced lot. This may range

between single, scattered units up to larger multi-unit housing projects. They are typically smaller and more energy-efficient than traditional housing.

Funding is extremely time limited. CMHC is accepting applications from municipal/provincial governments, Indigenous governing bodies and organizations, and non-profit organizations until December 31, 2020. Proponents will be required to commit all funds before March 31, 2021 and achieve occupancy within 12 months of the effective date of the contribution agreement with CMHC (no later than March 31, 2022).

**Analysis:** The Housing and Homelessness Plan for Stratford, Perth County and St. Marys (2020-2024) calls for the ending of homelessness and the creation of more attainable housing options in the community.

According to the By Name List, there were 101 individuals experiencing chronic homelessness in Stratford, Perth County and St. Marys as of October 31, 2020. Due to a complexity of issues, people with acute mental health and addiction issues do not always fare well in community housing or the private market, and these clients often place a significant strain on the resources of the City's Social Services Department, as well as other community partners (e.g. police, hospital, etc.). A best practice is housing individuals with high acuity needs in permanent low-barrier affordable housing units, with on-site 24/7 support staff.

The Social Services Department is currently investigating the opportunity to use RHI funding to construct an alternative housing pilot on a City-owned parcel of land at 398 Erie St., Stratford. This property was originally purchased for the expansion of the Stratford Fire Department but is no longer required for this purpose. It is currently being used as a temporary isolation space for individuals experiencing homelessness during COVID-19. It has been selected as the location for this pilot because is it City-owned, accessible by transit, and near community resources. Should the CMHC funding proposal be successful, then the Social Services team will work collaboratively with the Planning and Developmental services staff to ensure that neighbours and interested community members are engaged and consulted.

The initial concept plan calls for eight (8) modular units, which are well designed, integrated into the community, universally accessible and energy efficient. The units would be dedicated to single adults on the By Name List, who are experiencing chronic or episodic homelessness, and who are also dealing with complex mental health and addictions issues. There would also be 24/7 on-site staff which would be delivered in partnership with local social services and health agencies. The funding for ongoing operations (support staff and rent subsidies) would be provided through 100% provincial funds, such as the Community Homelessness Prevention Initiative (CHPI) and/or Home for Good (HFG).

**Financial Impact:** The Alternative Housing Pilot project will only proceed should the CMHC funding proposal for 100% RHI support of capital development costs be successful. The City would own and operate the pilot project, with funding for ongoing operations (i.e. maintenance expenses, rent subsidies and support services) to come from rental revenues and 100% provincial funding (CHPI and/or HFG).

It will also help support the forthcoming **Community Well-being and Safety Plan**, by increasing the availability of low-barrier affordable housing for individuals with complex mental health and addiction needs.
