1.0 Call to Order

(b) Update on Sign By-law Review

Patrick O'Rourke inquired if there were any updates regarding the comments that Heritage Stratford submitted to staff last year. Alyssa Bridge will investigate the status and update details of the proposed changes to the bylaw. Councillor Ingram stated there had been discussions regarding updating the bylaw at Planning & Heritage Sub-committee meetings. Members discussed where sign locations were or were not appropriate, signs within the HCD, illuminated signs, electronic variable signs and election-style lawn signs. There was an extensive list that the Sub-committee had asked staff to review.

(c) Update on Heritage Conservation District (HCD) Standards — Howard Shubert/Patrick O'Rourke

(d) Blue Plaque Update – Cambria Ravenhill

Barb Cottle created a spreadsheet to track all the nominations received for the blue plaques. Nominations are open until Friday, June 11, 2021. Roger Koert volunteered to do a follow-up radio spot to discuss the blue plaque program and remind people to send in their nominations by Friday. After the deadline, the Awards Sub-committee will review submissions and research the accuracy of the information provided over the summer and report back to the HS Committee in September.

The Committee has decided to postpone the event until July, pending phase 2 guidelines for holding gatherings. The certificates have been signed and framed and are ready to go for the event. Cambria Ravenhill will contact the venue to discuss arrangements.
