THAT the by-law to set the 2023 fees and charges for services performed by the City be approved as presented to take effect January 1, 2023.

Committee Discussion: A Council member requested that staff look at including the cost for garbage bag tags in the tax levy increase.

Discussion was held on the proposed increases of 2.5-3% and how staff arrived at that figure. Support was expressed for the current garbage bag tag system as it decreases garbage at landfill and extends its lifespan.

The Director of Corporate Services stated that there are several factors that affect fees and charges. It was suggested that current rates of inflation are not considered to be long term in nature and staff took a conservative approach to capturing that inflation impact. Consideration was given to whether the increases were sufficient. Specific fees can be revisited if necessary. With respect to the garbage bag tag fees, the Director of Infrastructure and Development Services advised that the garbage bag tag fees are taken directly from a 2021 waste rate study, which is based on future landfill closure and post-closure costs. There could be consideration to reducing the fee, but additional revenue would be required from the tax levy.

In response to questioning about working towards full cost recovery on certain fees, the Director of Corporate Services advised some fees are legislated to be full cost recovery, and some are at the full discretion of Council. Garbage bag tags were given as an example for an item that could be zero cost recovery and supported by the tax levy. The Chief Administrative Officer stated it is an initiative staff are working towards but there are various factors to be considered, including the waiver of fees during the COVID-19 pandemic. The proposed by-law is being brought forward at this time to have fees in place for 2023.

A request was made for transit rates to be frozen at their current rates. Reasons included wanting to increase ridership, assisting lower income riders, and that this is a service that is currently subsidized by the City and Province and Council has the discretion to increase that subsidization.

Concern was expressed regarding whether there is fairness around fees for different organizations, particularly organizations utilizing the Community Services facilities. It was suggested that an analysis would be instructive. The Chief Administrative Officer stated staff have begun an analysis through the service delivery review process. Expenditures and revenues are being tracked by individual facilities. Staff require that data to begin and analysis on what it costs to operate and maintain those facilities and to what level cost-recovery can be implemented. Staff are hoping to bring that report in 2023 when they have a full year of data.

Phase 1 is assessing the feasibility of the campaign, including assessing community and donor support for the Community Hub, identifying naming rights and other gifting opportunities, cultivating a donor prospect list, identifying potential campaign leaders and any potential public relations issues. If it is determined that there is sufficient support in the community for the project, staff would then recommend Phase 2 and 3 proceed.

It was suggested by Council members that it is important that a new Council starts off knowing what their responsibilities are. The Code of Conduct helps Council work better as a team and that an experienced Council knows what changes need to be made, whereas a new Council may not have a clear understanding of their roles at the beginning. Mayor Mathieson called the question on the motion.

application of the requirements of the Building Code, a collaborative approach to working with the building community and the assistance of the team in helping others achieve certifications.

Building and By-law Enforcement staff were thanked for their hard work and dedication in keeping the community safe.
