7. Orders of the Day:

7.1 ADDED - Resolution - Stratford Attainable Market Housing Project Final Report (COU23-064)

Joani Gerber, Chief Executive Officer of investStratford, Caroline Baker, of Baker Planning Group, and Kim McElroy, Director of Social Services, provided a PowerPoint presentation regarding the Stratford Attainable Market Housing Project. Highlights of the presentation included:

- acknowledgement of the teamwork and collaboration required to bring this project together;
- the project being about workforce as it relates to the involvement of investStratford;
- 40-60% of the workforce in the City commuting into the City each day for work;
- the report being received today and the project continuing forward;
- an overview of the attainable housing project to date including previously adopted Council recommendations;
- deliverables having been modified midway through the project due to Bill 23;
- the role of the Social Services Department in the attainable housing project;
- related programs and services being administered by the City's Housing Division;
- attainable housing being affordable, available, appropriate, and achievable;
- affordable and community housing being forms of attainable housing;

- the proposed attainable housing definition for the project and being quantified at a future date by the province;
- the increase in attainable housing relieving the pressure on affordable housing in the City;
- an additional landlord survey having been conducted as a part of public consultations;
- the need to guarantee maintained attainable housing;
- the Community Incentive Toolkit including both financial incentives and supports through proposed municipal programs;
- the need for more clarity around some definitions within Bill 23 in order to identify the impact on the project;
- recommending incentives from the toolkit be reviewed by staff to prepare a report regarding a draft community improvement plan for consideration during 2024 budget deliberations and a public meeting being required;
- a review of resources being needed to ensure an appropriate staff compliment for project implementation;
- the opportunity for surplus land grants and reviewing available land for a pilot housing project;
- an overview of sample design plans and cost analysis if choosing to proceed with a pilot housing project;
- recommending staff review a municipal surplus land policy and bylaw and prepare an options report for Council's consideration;
- recommended monitoring of 150 McCarthy Road West for future infrastructure improvements;
- project supports being considered during a future comprehensive Official Plan review;
- an awareness campaign proposed using social media posts and a website to help increase the supply of attainable housing in the City;

- written stories and videos being available online of residents who have been impacted by pressures of the housing market in Stratford; and,
- the recommendations being requested at this meeting not involving any financial commitments and just for staff to review the implementation plan and next steps.

Discussion was held with respect to:

- attainable housing quantified by the province at 90% of market value being an educated guess at this time and wanting to have that definition prior to returning to Council with a community improvement plan;
- being able to address inclusionary zoning and minimum parking restrictions through a comprehensive Official Plan review and amendments to the City's Zoning By-law; and
- the scope of this project not considering incentives from the federal government but future work on a sustainable community improvement plan could dovetail into work related to attainable housing.

Jane Marie Mitchell advised she was present to ask for a deferral for the approval of next steps of the project plan, especially the costing attached to the report. Ms. Mitchell stated there was not enough time for public to read, digest and analyze the report for it to be approved and that some public engagement like an open public meeting could assist. This was one item on an agenda that had 412 pages to be read and understood. Ms. Mitchell noted concerns she had with the City's Procedural by-law related to the timing and delivery of agendas. Returning to the report being considered, Ms. Mitchell requested that review of the project should include the City's Climate Change Program Manager as there is a need to

consider the climate and environment. Ms. Mitchell referenced a living wage employer that supported its employees in order to live and work in the City as it is difficult to find places for rent. Ms. Mitchell requested that this project be deferred in order to unpack the project and meet Stratford's needs.

Mike Sullivan congratulated the team involved on putting together something that is the beginning to help build more affordable housing. Mr. Sullivan stated he has reviewed the City's definition of attainable housing but believes this is just a definition for market housing. He further stated that attainable housing at 90% would not make Stratford affordable. He referenced average market prices being down 12% and three bedroom homes for rent being \$3,000 per month, with an average purchase price of \$680,000. Mr. Sullivan stated that the tools in the toolkit will not cover this gap, especially with the province taking away the use of development charges. He advised of an option to create a community land trust with respect to a potential housing pilot project. With respect to climate change, Mr. Sullivan stated more consideration was required and that ongoing costs could be reduced by making it a requirement that new homes are built as passive houses. Mr. Sullivan requested that the Climate Change Program Manager be included in the review of this project with the City's Corporate Leadership Team.

7.2 Resolution - Kelly Drain Engineering Report Consideration (COU23-062)

Joel Miller, Engineer, from K. Smart Associates Limited, provided a PowerPoint presentation regarding the Kelly Drain Engineering Report. Highlights of the presentation included:

- this being an existing municipal drain, built in late 1960's;
- a request having been received to repair the drain and the Drainage Act allowing for the drain to be improved;
- the drain being located at the corner of Road 11 and Line 37;

- communal drainage systems needing to be improved over time and the Drainage Act providing ways for it to be upgraded;
- the drain serving about 160 acres of land;
- 1,100 meters of pipe being proposed to be put in with estimated costs of \$240,000; and
- cost allocation for this project being determined through a Court of Revision.

Discussion was held between staff and members regarding no concerns having been received to date and impacted land owners being able to appeal their assessment through the Court of Revision.
