### **6.3 Transit Bus Electrification Feasibility Study Results (COM23-006)**

**Committee Discussion:** The Manager of Transit provided a PowerPoint presentation regarding the Transit Bus Electrification Feasibility Study Results. Highlights of the presentation included:

- HDR currently undertaking the study and identifying that it is feasible for Stratford to switch to battery electric buses (BEB's);
- the scope involving three tasks including feasibility and energy modelling, facility assessment and infrastructure requirements, and fleet transition planning;
- an overview of the number of electric buses required to sustain existing services and the cost required to purchase each;
- diesel or electric heat bus options and two different kilowatt electric versions being available to consider;
- consideration of a depot charging pathway for charging on route;
- the fleet transition plan being a 20 year plan to implement a fully electric bus fleet and costing approximately \$40 Million;

- potential transit savings being realized as the fleet transition plan is executed; and
- current diesel buses emitting approximately 1,343 tonnes of greenhouse gas emissions.
