7.2 Correspondence - Fire Prevention Week 2023

- Radio advertisements aired on CJCS promoting a message of fire safety;
- Two-page advertisement in the Stratford Beacon Herald;

- Fire Prevention booth set up at Stratford Mall (formerly Festival Market Place), inside Canadian Tire, with educational materials and a Fire Prevention Officer on hand to engage with the public; and
- Social Media Campaign throughout the City of Stratford social media platforms.

7.5 Resolution - Zone Change Application Z02-23, 203 and 209 Waterloo Street South, Stratford

Urja Modi, Intermediate Planner, from MHBC on behalf of the City, provided a PowerPoint presentation regarding zone change application Z02-23. Highlights of the presentation included:

- a public meeting having been held on August 14, 2023, with no comments received;
- the application proposing a 10 unit residential building with 11 parking spaces and 1 accessible parking space;
- staff no longer recommending that a holding provision be placed on the subject lands as required noise implementation measures can be achieved through site plan control;
- · the road widening already having been conveyed;
- the subject lands being designated downtown core;
- the proposed development being a permitted use under the City's Official Plan; and
- comments having been received from agencies and city departments, including concerns from CN Rail requiring a noise and vibration study to be undertaken.

A question and answer period was held with respect to:

- the noise and vibration study being implemented through site plan control;
- Bill 23 initially exempting developments with 10 units or less from site plan control; and
- proximity to CN Rail providing for ability to take application through the site plan control process.

Tracey Pillon-Abbs, Principal Planner for the applicant advised they were in support of the staff recommendation, including that the initial request for a holding provision be replaced with site plan controls to streamline and complete a noise and vibration study.

Discussion continued with respect to:

- the request from CN Rail not having been asked for in the past and administration working to figure out how best to move forward;
- allowing development to occur under proper conditions through site plan control;

- the development prior to Bill 23 being required to go through site plan control;
- there being little mechanism to impose requirements through an agreement without site plan control;
- agency comments from CN Rail under the Planning Act requiring the development to go through site plan control when it otherwise would not have; and
- a conveyance no longer being required as the road widening has already been granted to the municipality.

The City Clerk clarified that the recommendation was to add that the development be subject to site plan control and remove the holding provision requirement.

THAT application Z02-23 to amend the site-specific zoning at 203 and 209 Waterloo Street South to add the use of Cluster Townhouse Dwelling and to permit reduced front yard setbacks and walkways widths BE APPROVED for the following reasons:

- 1. The request is consistent with the Provincial Policy Statement;
- 2. The request is in conformity with the goals, objectives, and policies of the Official Plan;
- 3. The zone change will permit a residential development that is appropriate for the subject lands; and
- 4. The public were consulted during the application circulation and comments that have been received in writing or at the public meeting have been reviewed, considered, and analyzed within the Planning Report.

AND THAT Council require that the proposed development be subject to Site Plan Control in accordance with Section 41 of the Planning Act, RSO 1990, in order to implement the recommendations of a Noise and Vibration Study to address CN

Rail's requirements for such studies in close proximity to rail operations.

7.6 Resolution - Zone Change Application Z03-23, 473 Douro Street and 160, 169 and 172 Frederick Street

Urja Modi, Intermediate Planner, from MHBC on behalf of the City, provided a PowerPoint presentation regarding zone change application Z03-23. Highlights of the presentation included:

- a public meeting having been held on August 14, 2023, with no comments received;
- the application seeking to amend the Zoning By-law to implement consent applications;
- Zoning By-law amendment to implement consent applications;
- parcel 1 of the subject lands not having any amendments;
- parcel 2 of the subject lands having an amendment regarding lot depth;
- parcel 3 of the subject lands being proposed for light industrial uses;
- parcel 4 of the subject lands to become a parking area;
- staff having modified permitted uses for light industrial to remove animal shelter as a permitted use;
- a holding symbol being placed on parcels 3 and 4 until the completion of a noise study;
- the site currently designated as industrial under the City's Zoning By-law;
- Engineering staff comments being received regarding the conveyance of a 1.4 meter road widening and requirements of storm water management which will be addressed during site plan control;
- public concerns received and being reviewed further through site plan control including storm water management and potential

flooding on abutting lots, impacts on property lines and approximal hedge, and traffic impacts on the area; and

 it not being anticipated that the application will have any impact on abutting properties.

Discussion was held with respect to:

- confirmation that it will be light industrial uses permitted at 172
 Frederick Street; and
- the noise study accounting for any permitted uses under light industrial with the exception of an animal shelter.

Tracey Pillon-Abbs, Principal Planner for the applicant advised they were in support of the staff recommendation. Further, they are also supportive of going through site plan control and the implementation of a holding provision.

THAT application Z03-23 to amend the site-specific zoning at 473 Douro Street and 160, 169 and 172 Frederick Street to permit: reduced lot areas, lot frontages and lot depths; limited light industrial uses on 172 Frederick Street, as altered by Staff; and, the off-site location of required parking at 169 Frederick Street servicing 172 Frederick Street BE APPROVED for the following reasons:

- 1. The request is consistent with the Provincial Policy Statement;
- 2. The request is in conformity with the goals, objectives, and policies of the Official Plan;
- 3. The zone change will permit the development of additional industrial buildings on underutilized lands;
- 4. The zone change will satisfy the conditions of the provisionally-approved consent to sever applications (B01-23 & B02-23) for the subject lands; and

5. The public were consulted during the application circulation and comments that have been received in writing or at the public meeting have been reviewed, considered, and analyzed within the Planning Report.

AND THAT Council place a Holding Symbol on the subject lands to limit the permitted uses on the site municipally addressed 172 Frederick Street to existing, legally established uses in existence on the date of passing of the Bylaw, and to limit the permitted uses on the sites municipally addressed 473 Douro Street and 160 Frederick Street to all permitted uses of the General Industrial (I2) zone for the following reasons:

1. To warrant the submission of a Noise Impact Study to the City, to the satisfaction of the City, to evaluate and mitigate potential adverse noise impacts on the surrounding residential land uses.

AND THAT Council pass a resolution that no further notice is required under Section 34(17) of the Planning Act, for the following reasons:

1. The alterations to the proposed Zoning By-law Amendment proposal are minor in nature, being limited to the placing a Holding Symbol on the Subject Lands requiring the completion of a Noise Study prior to deeming a Site Plan Approval for 172 Frederick Street and, the removal of a requested use from the list of permitted light industrial uses for 172 Frederick Street.

- it being reported that the fee for single swim family decreased but the schedule identifying a cost of \$16; and
- consideration for family passes of skating and aquatics both being \$15.

It was stated that for Council to receive this petition, petition organizers must submit it before October 3, 2023, and that the petition would then be presented at the October 10, 2023, Council meeting.

Mayor Ritsma advised that his office has been in contact with both levels of government and the local MPP to get an audience with Metrolinx. It was confirmed that this is a concern of staff and the Mayor's Office, of which both are pursuing VIA and Metrolinx to come to the table for discussions. It was further advised that Transport Canada continues to work on a proposal and long term solution.
