THAT the City of Stratford lower the flag at the front of Stratford City Hall on December 6, 2023 in recognition of the massacre of 14 women at Ecole Polytechnique.

Discussion was held with respect to:

 an overview of the massacre of 14 women that occurred at Ecole Polytechnique on December 6, 1989, being provided;

- Bill C-68 having enacted the Firearms Act in 1995;
- December 6 being the National Day of Remembrance and Action on Violence Against Women, also known as White Ribbon Day;
- the month of November being Woman Abuse Prevention month;
- the June 28, 2022 Renfrew inquest into the deaths of three women who were killed on September 22, 2015;
- United Nations Women having declared violence against women to be a shadow pandemic in May of 2020;
- Optimism Place having received 2,144 calls to their crisis line in 2021 and serving 58 women and 36 children in their residential program;
- calls for service continuing to increase and Optimism Place being in the process of a facility expansion; and
- Stratford City Council having passed a resolution declaring intimate partner violence an epidemic on May 23, 2023.

A Point of Order was raised with respect to there already being a motion on the floor. The City Clerk clarified that an amending motion had been put forward to amend the main motion in accordance with the Procedural By-law.

Discussion continued with respect to:

- parking tickets disproportionately impacting people and an increase in parking ticket costs potentially deterring downtown visitors;
- retailers needing constant flow of parked cars and being aligned with set fines imposed by other municipalities making sense;
- patrons not being subject to certain ticket fines if payment of parking fees is made;
- reducing the proposed set fines to encourage people to visit the downtown;
- parking fees impacting downtown parking more than parking fines;
 and
- the benefit of the HotSpot application allowing patrons to add time to their parking session to avoid receiving a ticket.

Deputy Mayor Nijjar called the question on the amending motion.

Defeated
