- staff intending to review definitions for affordability and affordable housing;
- municipalities incentivizing developers to make homes more accessible and affordable but having limited tools to make it a requirement;
- looking at options to include language in the Official Plan regarding geothermal heating; and
- advocating for affordable housing and tiny home communities similar to what is seen in the Waterloo Region.
