### 4. General Business

#### 4.1 Alternative Measures for Providing Notice of Public Hearing

Provide direction under rule 3 of by-law 113-98

For the Committee's consideration, planning staff suggest the following:

That given the disruption in service by Canada Post, that notices be hand-delivered to property owners within 60 metres of the subject lands for any application and that for property owners with mailing addresses outside the City of Stratford, that staff make arrangements for notice delivery by courier; that all applicants be responsible to cover such associated costs which are beyond the application fee, and

That once the Canada Post disruption in service has been resolved, that notice of any hearing shall be given by prepaid first class mail.

**Committee Discussion:** Discussion took place between Committee members and staff. Highlights of the discussion included the following:

- Canada Post having resuming service with staff understanding potential for future disruption as labour negotiations are continuing;
- the intention to provide clarity on application processing going forward with alternative delivery methods for future disruptions;
- application processing to proceed with Canada Post service delivery in January, 2025, and to hand deliver notices should further postal services disruption occur;
- December 18 hearing items having been rescheduled for January with subsequent notice prepared to inform the public and the applicant.
