This report summarizes the proof of concept, impact, cost and recommendation for the Stratford Primary Care and Homecare Symposium entitled, <u>Discover the Future of Homecare</u>. The purpose of the symposium was to build a broader awareness of the role of homecare services in our Stratford area's broader healthcare system.

Proof of Concept: The registrants, speakers, moderators and volunteers expressed uniform praise for the day's homecare information and learning format. With a "grassroots" flavour the program tapped into a thirst for learning more about aging in place and homecare.

Impact: The Symposium generated an awareness of homecare in our healthcare system. It also brought an awakening of inquiry and interest in the need to take further action surrounding homecare needs and services for older adults in Stratford and area. The Symposium spawned:

- A Symposium wrap-up by UWaterloo PhD student Nancy Orr.
- A Symposium Report prepared by UWaterloo graduate student Emily Gorgenyi.
- Follow-up discussions with the UWaterloo's <u>Network on Aging Research</u> (NAR).
- Registrant enquiries about the nature of Naturally Occurring Retirement Communities (NORCs) and where to go for help.
- A Brunswick St. neighbours collaborative coordinated by one of the Symposium moderators...Thérèse Chatelain.
- A "Calling All Seniors" gathering by symposium speaker Dr. Jean Hewitt on June 27^{th.}
- A meeting with a local retirement home.
- An awareness of GTR design possibilities for aging in place in our community.
- A wide regional footprint with registrants coming from 9 municipalities, 23 community agencies and internationally recognized speakers.
- A request to help coordinate a fall tour stop of the Ontario Primary Care Action Team.

Symposium Cost: With the City of Stratford's seed funding, matched by sponsorship support, the Homecare Symposium came in well under budget while bringing added value to our community's healthcare needs. A revenue and expense statement has been presented to the City of Stratford's Director of Finance.


