4. Report of the Manager of Children's Services

4.1 Access to Licensed Childcare in Stratford, St. Marys, and Perth County (SOC25-011)

Staff Recommendation: THAT the report titled, "Access to Licensed Childcare in Stratford, St. Marys, and Perth County" (SOC25-011), be received for information.

Sub-committee Discussion: The Manager of Children's Services provided an overview of the report. Highlights included the following:

- the report providing a review of access to licensed childcare in the area particularly for children from birth to 4 years of age;
- access to childcare for 8 hours per day or more, for 12 months annually prior to school entry at kindergarten having the greatest impact;
- childcare allowing parents to hold full time employment with economic benefits occurring across the lifespan;
- benefits including immediate impacts of increased labour force participation, reduction of income inequality, and long term impacts of a positive early learning environment on decreasing developmental vulnerability;
- Stratford, St. Marys and Perth County access to full day, year round childcare for these ages remaining low;
- a correction to the data presented in the report being noted, specifically that the 88 spaces indicated to be opened in Perth County in 2025 will not be opened until a later date;

- it being expected by the end of 2025 that 16% of children from birth to age 4 across Stratford, St. Marys and Perth County will have access to full time care, and representing 15% in Stratford; and
- continued efforts to increase local access being required with not enough childcare at this time.

5. Report of the Homelessness and Housing Stability Supervisor

5.1 Homelessness Individuals and Families Information System (HIFIS) update (SOC25-010)

Sub-committee Discussion: The Homelessness and Housing Stability Supervisor provided an overview of the report. Highlights included:

- as the Consolidated Municipal Services Manager (CMSM) the City of Stratford being the lead agency in homelessness response for Stratford, St. Marys and Perth County;
- internal staff having been trained in the use and implementation of the Homelessness Individuals and Families Information System (HIFIS);

- HIFIS being used to track and share resources to best support the vulnerable populations in each municipality;
- the intention being to expand HIFIS to community partners allowing for streamlined resources with community partners and the City's contracted after hours provider;
- the expansion being to better serve clients, share information and case plan for permanent housing stability; and
- authority to sign data sharing agreements with community partners to streamline this process and allow for more rapid training of agencies.

Discussion occurred between Sub-committee and Staff. Highlights of the discussion included the following:

- staff provided clarification that Shelterlink Youth Services is the City's contracted provider for after hour services with the relationship having been successful and being mutually beneficial;
- Shelterlink being contracted to assess ongoing needs after hours including providing ongoing emergency needs, diversion strategies to assess the needs of unhoused individuals and to make a plan for outcome and eligibility requirements;
- in response to a Member's question, staff noted that if an individual is deemed eligible for emergency accommodations this can be provided after hours.

6. Department Update

Sub-committee Discussion: The Director of Social Services provided an overview of the Department Update and noted a variance report is being prepared. Members of Sub-committee and Staff discussed the update highlighting:

- 144 households experiencing homelessness which includes individuals who are couch surfing, living with family or may be unsheltered;
- a Member asking if there is an expectation that the homelessness numbers will increase or decrease;
- it being noted that the City does not have any evidence based data to predict this;
- the Association of Municipalities of Ontario (AMO) having circulated a report with projected numbers that indicated an increase in homelessness is expected but this being dependent on different factors;
- 115 individuals experiencing homelessness from the By Name List having been housed between June 2024 and June 2025 and this being good progress;
- much work to be done in housing stability to ensure individuals are not re-entering homelessness;
- regarding a plan for the winter season, work being done with the Ending Homelessness Group and the Council of Churches to look at options as directed by Council at the September 8, 2025 meeting;
- emergency accommodations having been used successfully for many years to house individuals during the winter season;
- it being questioned whether the temperature of -15 degrees Celsius with windchill for emergency housing is mandated or if it can be changed;
- staff noting the temperature in the policy can be changed;

- -15 degrees with windchill being based on best practices as seen in other municipalities and due to the impacts of being outside for extended periods of time at this temperature;
- emergency housing length of stay varying based on the circumstances of the individual with shorter or longer stays depending on weather, and or engagement in future housing opportunities available;
- a Member noting winters are getting colder and questioning whether -10 with windchill should be considered; and
- staff to assess best practices and investigate if there have been any changes in municipalities emergency housing policies during winter months.

Title: Access to Licensed Childcare in Stratford, St. Marys, and Perth County

Objective: To provide Sub-committee with an update on access to licensed childcare in Stratford, St. Marys, and Perth County, and review the value of access to affordable, high-quality, licensed childcare to the economy.

Background: Licensed childcare is a significant economic driver, supporting a family's participation in the labour force. The economic importance of access to licensed childcare has been communicated by the Government of Canada and provincial governments with introduction of the Canada-Wide Early Learning and Childcare (CWELCC) System and the vision that families may "access to high-quality, affordable, flexible, and inclusive early learning and childcare no matter where they live". In support of this vision, the Province of Ontario set a target of improving the provincial average access rate for children from birth to age 5 to 37% by 2026.

To best support full labour force participation, it is availability of full-time, year-round access to licensed prior to school entry (e.g. 8 or more hours of care per day, from birth to age 4) that has the greatest impact, allowing parents to hold full-time employment. Affordability for these highest-cost spaces was greatly improved with introduction of the CWELCC System. While this resulted in a corresponding increase in demand for licensed childcare spaces and created challenges in accessing licensed childcare for many families, it is also positively correlated with improved labour force participation for coreage women (25-54 years), which reached a record-high of 79.7% in 2023.

Public investments into licensed childcare show a strong return on investment, estimated to be about \$6 for every dollar spent in the Canadian context. The economic benefits occur across the lifespan. These include the immediate impacts of increased labour force participation and reduction of income inequality, to the long-term impacts of positive early learning environments on decreasing developmental vulnerability, shown to be a lifelong predictor of health, learning, and behaviour.

Through the Ministry of Education's Capital Priorities program, which supports the creation of licensed childcare spaces in conjunction with school infrastructure projects, 176 new full-day, year-round spaces are expected to be opened this year in Perth County. These spaces resulted from successful applications made by school boards and endorsed by the City of Stratford. Within Stratford, it is further expected that a new, 98-space centre operated by for-profit, child care operator will be opened in 2026. While progress towards equity of access to licensed childcare is being made, most families remain without access to a space; this will remain true provincially even if the target access rate of 37% is achieved.

Analysis: While the Province of Ontario has set a target for a provincial access rate of 37% for children from birth to age 5, the service delivery area of Stratford, St. Marys, and Perth continues to fall short of this target. By the end of 2025, it is expected that the access rate for these age groups in the area will reach 22.8%, however access to full-day, year-round care children prior to school entry remains low, as shown in the chart below:




Figure 1: Percent access is calculated using the population of children from birth to age 4 (Statistics Canada) and the number of licensed infant, toddler, preschool, and family age group spaces projected to be licensed by November/ December 2025 (City of Stratford Service Data).

Perth South currently has no licensed childcare spaces and is not shown on this chart.

The access rate for full-day, year-round licensed childcare in Stratford is 15%, which is below the average of 17% across the service area. The inclusion of part-time (e.g. nursery school) spaces provides for some level of licensed childcare for up to 21% of the Stratford population from birth to age 4. The addition of the 98-spaces planned for

2026 will increase the access rate to full-day, year-round licensed childcare to 27% in Stratford.

While families may seek care outside of the municipality in which they live, this data provides for an understanding of the extent to which families' full labour force participation may be supported through the access to full-day, year-round licensed childcare in Stratford, St. Marys, and Perth County through 2026, and shows that there is not enough licensed childcare for those who need it.

As Service System Manager (SSM) the City was provided with a growth target of 461 spaces for the service area over the period of 2023-2026 (see report SOC25-007 "Canada-Wide Early Learning and Childcare Implementation Update and Directed Growth Priorities"). Including the 274 approved spaces described above, there remain at least 187 spaces available for growth to the end of 2026. Achieving the complete target of 461 spaces will provide an access rate of just 27% across Stratford, St. Marys, and Perth County for children from birth to age 5, including all part-time and kindergarten spaces.

The Children's Services Division continues to explore opportunities to create new licensed childcare spaces in collaboration with community-based childcare operators, and advocate to the Province of Ontario on recognizing and addressing the unique needs related to the creation of new licensed childcare spaces in small urban and rural communities.

Financial Implications:

Financial impact to current year operating budget:

The spaces being developed in 2025 are not expected to have any net impact as these projects have been supported with Ministry of Education funding.

Financial impact on future year operating budget:

The 98-space centre being created in 2026 is also not anticipated to impact the City's core revenue and expenses as budgeted. Infrastructure funding to support this project is 100% Provincial/Federal funding and minimum municipal cost-share requirements for child care operating costs are not impacted.

Not applicable, as these initiatives will not result in City assets and relate to program funding.

Title: Update to Access to Licensed Childcare in Stratford, St. Marys, and Perth County

Objective: To provide Committee with an update regarding information presented in the report Access to Licensed Childcare in Stratford, St. Marys, and Perth County (SOC25-11).

Background: The report Access to Licensed Childcare in Stratford, St. Marys, and Perth County (SOC25-11) reviews access to licensed child care in Stratford, St. Marys, and Perth County, particularly for children from birth to age 4. The report describes that 176 new full-day, year-round spaces are projected to be opened this year in Perth County, and that this will provide for an average access rate of 17% across the service delivery area.

Analysis: This report shares a correction, as 88 of the spaces indicated to be opened in Perth County in 2025 will not be opened until a later date. By the end of 2025, it is thereby expected that just 16% of children from birth to age 4 across Stratford, St. Marys and Perth County will have access to full-time care.

An updated chart showing the projected potential access to full-day, year-round licensed childcare from birth to age 4 by December 2025 is shown below:




Figure 1: Percent access is calculated using the population of children from birth to age 4 (Statistics Canada) and the number of licensed infant, toddler, preschool, and family age group spaces projected to be licensed by November/ December 2025 (City of Stratford Service Data).

Perth South currently has no licensed childcare spaces and is not shown on this chart.

Title: Homelessness Individuals and Families Information System (HIFIS) update

Objective: To provide the Social Services Sub-committee an update on the implementation of HIFIS as expansion begins to onboard external community partners, as well as obtain delegated authority to sign Data Sharing Agreements with agencies as part of our Coordinated Access System of support within Stratford, St. Marys, and Perth County.

Background: As the Consolidated Municipal Service Manager (CMSM), the City of Stratford is the lead agency in homelessness response for the City of Stratford, St. Marys, and Perth County. As part of this response, we are regularly looking at how we can best communicate with community partners, share resources, and follow industry best practices to support the vulnerable populations served in each municipality.

With this, the City is excited to announce the external launch and onboarding of HIFIS to external community agencies. Through this expansion, there will be streamlined resources with community partners and the City's contracted after-hours response, allowing for improved communication and delivery of services. As training of new agencies is begun and implemented, the ability to sign off on data sharing agreements is required to ensure all Coordinated Access partners into HIFIS are consistently onboarded.

Analysis: Through the expansion of HIFIS and assisting with the implementation across the Coordinated Access System, the City will be able to better serve clients, share information, and case plan for longer term success in permanent stable housing. Authority to sign Data Sharing Agreements with community partners will streamline this process and allow for a more rapid training of agencies.

Financial Implications:

Financial impact on current year operating budget: Staffing costs associated with training external community agencies with this project is included in the approved operating budget. No further costs are anticipated as the Homeless Individuals and Families Information System (HIFIS) is a Canadian federal data collection system, and not a service with a direct cost to users.

Financial impact on future year operating budget: There are no future year operating cost impacts anticipated for this project.














