Re: Local Improvement Roadwork, Moderwell Street from St. Vincent Street South to **Monteith Avenue**

Please consider this letter the Huron-Perth Catholic District School Board's response to the City's Notice of Intent to Adopt Local Improvement Charges By-Law (Ontario Regulation 586/06 of the Municipal Act, 2001) as it relates to the local improvement roadwork on Moderwell Street from St. Vincent Street South to Monteith Avenue. The Board's school, St. Joseph's Catholic Elementary School, is located at 363 St. Vincent Street South with a frontage of 160.934 metres and the estimated cost to the Board for this work is \$42.598.09. As a school property, the Board is exempt from paying property taxes. With this in mind, the Board is requesting relief from paying the estimated costs for the Local Improvement Charges.
