We would support the proposed application as long as there is no road access for the apartment onto Kastner Street. We purchased our home because of the quiet street and low traffic volume.

For the attention of council, as an addendum to today's agenda.

I wish to raise some observations about the proposal from Cordelia BESS.

First, the site already has Canada's largest Battery Energy Storage System, originally installed by Arcadian Projects of New Hamburg. The owner, POWIN systems went bankrupt in July. In the US its assets were transferred to a company called Flexgen in Durham, North Carolina, but it is my understanding that festival Hydro now runs the facility. It is unclear how this new proposal will interact with the existing facility.

Second, the proposal is from a company which only Incorporated on September 25 of this year so it is unclear what their history and resume is. The CEO of the corporation is also the Controller of Energyplug, which has changed its name to Aegis. That company lists on its website several advisors, and I encourage you to look up that website.

In addition, the choice of name for this corporation may be confusing. There is a very large and well organized energy corporation called Cordelio power systems and there is another company operating in the US called Cordelia power systems. Cordelio operates in Canada as well as the US. The proposal is from a third corporation with a similar or same name.

The letter from the CEO suggests the facility would be used for 'peak shaving' whereby class A hydro users minimize or avoid the 'global adjustment' which is over half of our electricity price. It also suggests that the facility could help with power outages. Has the city considered peak shaving to lower its electricity bill?

BY-LAW NUMBER XXX-2025 OF THE CORPORATION OF THE CITY OF STRATFORD

BEING a By-law to authorize the entering into and execution of a Service Agreement with Ward & Uptigrove Human Resources Solutions for the provision of human resources support services from January 1, 2026 to December 31, 2026.

WHEREAS Section 8.(1) of the Municipal Act, 2001, S.O. 2001, c.25, as amended, ("the Municipal Act, 2001") provides that the powers of a municipality under this or any other Act, shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS Section 9 of the Municipal Act, 2001, provides that a municipality has the capacity, rights, powers and privileges of natural persons for the purpose of exercising its authority under this or any other Act;

AND WHEREAS Section 10(1) of the Municipal Act, 2001, provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

AND WHEREAS The Corporation of the City of Stratford and Ward & Uptigrove Human Resources Solutions wish to enter into a service agreement for the provision of human resources support services from January 1, 2026 to December 31, 2026;

NOW THEREFORE BE IT ENACTED by the Council of The Corporation of the City of Stratford as follows:

1. That a Service Agreement between The Corporation of the City of Stratford and Ward & Uptigrove Human Resources Solutions, for the provision of human resources support services from January 1, 2026 to December 31, 2026, be entered into and the Mayor and Clerk, or their respective delegates, be and are hereby authorized to execute the said Agreement on behalf of and for this Corporation and to affix the corporate seal thereto.
