2887. BOARD OF PARK MANAGEMENT POLICY ENDORSEMENT:

Background: Several times a year contractors request permission to cross parkland to access private property. Historically the Parks Division has requested a retainer of \$1,000.00 for every 100 hundred feet of access. These funds are retained and returned to the applicant following completion of a project and area rehabilitated to pre-project condition.

The request for the Board is to endorse this procedure so a formal policy can be consistently implemented for requested contractor usage.
